**Job Description**

**Licensed Associate Professional Counselor (LAPC)**

**General Description:**

**Full-time, Temporary.** To provide individual and group counseling to child, adolescent and adult victims of sexual violence and child maltreatment and their significant others and/or non-offending caregivers. On-call, nights, and weekends required. Must live within 30 minutes of Hampton, GA. Travel required for training and as needed to Hampton, GA. Reports directly to the Program Director.

**Specific Duties:**

- Provides individual therapy for victims of sexual abuse and child maltreatment.
- Organizes/conducts group counseling sessions for victims and their non-offending caregivers.
- Screens potential participants for involvement in support groups.
- Identifies resources for clients in need of long term counseling services.
- Assists clients in utilizing all resources available in the community.
- Manages and maintains client case files.
- Participates in the multi-disciplinary team process for cases involving children.
- Participates in training of community professionals about the issues surrounding child abuse.
- Submits reports and statistical data as required by grant funders and agency partners.
- Participates in supervision in order to meet licensing requirements for the state of Georgia.
- Will have a minimum of 20 hours of training prior to unsupervised contact with a victim.
- Will have a minimum of 10 hours of ongoing training annually.
- Performs related duties as assigned.

**Minimum Qualifications:**

- Master's degree in counseling, social work, or related field.
- Professional associate counselor licensure (LAPC) by the State of Georgia.
- Willingness to become certified in Trauma Focused-Cognitive Behavioral Therapy (TF-CBT)
- Maintains current liability insurance.
- Competent knowledge and understanding of the issues surrounding sexual assault and child maltreatment.
- Excellent verbal and written communication skills.
- Ability to organize and maintain accurate records.
- Ability to empathize and communicate clearly with all types of people.
- Commitment to the need for client and agency confidentiality.

**Preferred Qualifications:**

Previous experience providing individual and group counseling to victims of abuse.
